

In order to obtain the Material Health Certificate, all chemicals used in the value chain must be analysed and evaluated with regard to health and environmental hazards. Dangerous chemicals are avoided and replaced with safer substances – for sustainable production.

FSC™-certified natural rubber is used in our squeegee rubbers – for more sustainable forest management. FSC™-certified forests and plantations are managed according to stricter environmental and social principles. FSC™-certified materials can be traced throughout the supply chain at all times.

The European Commission awards the EU Ecolabel to products that have a lower environmental impact than comparable products and are therefore healthier and more environmentally friendly. The criteria differ depending on the product group. In the case of textile and cleaning products, evaluation is based on the proportion of recycled materials, the limitation of toxic chemicals, the biodegradability as well as the cleaning performance and durability.
